Refund Policy

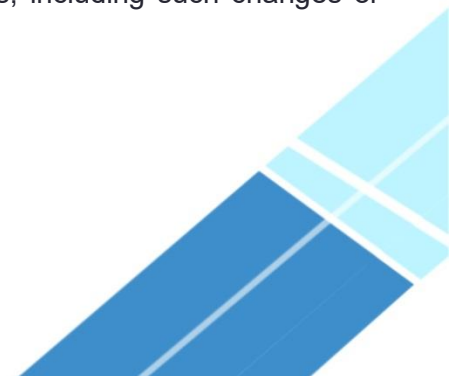
